ORDER GRANTING RESPONDENT'S MOTION TO EXTEND
TIME FOR FILING AN OPPOSITION TO COMPLAINANT'S
MOTION FOR PARTIAL SUMMARY JUDGMENT AND GRANTING
COMPLAINANT'S MOTION FOR CONTINUANCE OF HEARING

On October 18, 1995, Respondent LINDA LINGLE, Mayor, County of Maui (County), by and through her attorneys, filed a motion to extend the time for filing her opposition to Complainant's motion for partial summary judgment with the Hawaii Labor Relations Board (Board). Respondent's counsel requests an extension of time from October 16, 1995 to October 18, 1995 within which to file his brief. Respondent's counsel apparently needed an extension and requested an extension from Complainant's counsel. Respondent's counsel states in an affidavit attached to the motion that counsel for Complainant agreed to the two-day extension of time.


For good cause shown, the Board hereby grants the County an extension of two days within which to file its brief.

Also on October 18, 1995, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA/AFSCME), by and through its attorney, filed a motion for continuance of hearing with the Board. Complainant requested that the Board continue the date of the hearing scheduled on October 27, 1995 at 9:00 a.m. to November 9, 1995 at 10:00 a.m. Complainant's counsel requests the continuance in order to respond to Respondent's memorandum in opposition since he agreed to extend the time for the County to respond and also because of a scheduling conflict. In addition, Complainant's counsel requested that the Board hear its motion for partial summary judgment rather than hold the hearing on the merits of the complaint.

For good cause shown, the Board hereby grants Complainant's motion. The Board will conduct a hearing on HGEA/AFSCME's motion for partial summary judgment on November 9, 1995 at 10:00 a.m. in its hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii.
