ORDER GRANTING RESPONDENTS' MOTION TO CONTINUE HEARING; NOTICE OF RESCHEDULED HEARING

On July 29, 1996, Respondents, by and through their attorneys, filed a motion to continue the hearing scheduled on August 8, 1996 in this matter with the Hawaii Labor Relations Board (Board). Respondent RAYMOND Y. KOKUBUN (KOKUBUN) states in an affidavit filed in support of the motion that he will be away on a long-scheduled vacation during the week of August 5, 1996, and he was subpoenaed by Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) to appear at the hearing. KOKUBUN requested that the Board continue the hearing sometime after his return.

Thereafter, on July 30, 1996, Complainant UPW filed a response to Respondents' motion to continue with the Board. The UPW submits that if the Board is inclined to grant the continuance in this matter, the UPW requests that the hearing be rescheduled during the week of September 23, 1996, with the requirement that KOKUBUN produce all documents subpoenaed no later than August 8, 1996, and to appear per the subpoena on the date which the hearing is rescheduled. Further, the UPW sought to clarify the circumstances leading to the filing of Respondents' motion to continue. In addition, the UPW indicated that it opposed the motion and that it did not waive its rights under the applicable rules.

After reviewing Respondents' moving papers and the UPW's response thereto, the Board hereby grants the motion for good cause shown. In addition, KOKUBUN is ordered to appear at the rescheduled hearing and is further ordered to produce the subpoenaed documents no later than August 8, 1996.

YOU ARE HEREBY NOTIFIED that the Board will conduct a hearing on the above-entitled complaint on September 24, 1996 at 9:00 a.m. in Wailuku, Maui. Counsel for Respondents is requested to assist the Board in obtaining a site for the hearing. Appropriate provisions of the notice issued on June 4, 1996 remain applicable.
