ORDER GRANTING COMPLAINANT'S MOTION TO
CONTINUE HEARING; NOTICE OF RESCHEDULED HEARING

On July 28, 1997, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its attorney, filed a motion to continue the hearing scheduled on August 6, 1997 with the Hawaii Labor Relations Board (Board). Counsel for the UPW states in an affidavit attached to the motion that he is

scheduled to appear in the Third Circuit Court on that date to participate in injunctive proceedings and thus requests a continuance of the hearing in this matter for 30 days.

Thereafter, on July 31, 1997 Respondents BENJAMIN J. CAYETANO, Governor, State of Hawaii and JAMES H. TAKUSHI, Director, Department of Human Resources Development, by and through their attorney, filed a memorandum in opposition to Complainant's motion to continue the hearing. Respondents contend that this hearing has been continued since February 20, 1997 after the close of Complainant's case. The hearing has been continued numerous times at Complainant's request and over Respondents' objections. In the event that a continuance is granted, however, Respondents request that the hearing be rescheduled to October 1 or 3, 1997.

After reviewing the record in this case, the Board finds merit in Respondents' objections to the continuance. However, as Complainant's counsel is unable to attend the hearing as scheduled due to an appearance in the Third Circuit Court, the Board hereby grants the UPW's motion for continuance.

YOU ARE HEREBY NOTIFIED that the hearing in this matter is rescheduled to October 1, 1997, at 9:00 a.m. in the Board's hearings room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii. If necessary, the hearing will continue on October 3, 1997.




