ORDER GRANTING LINDA CROCKETT LINGLE, MAYOR,
COUNTY OF MAUI AND COUNTY OF MAUI'S MOTION TO DISMISS

On November 10, 1997, LINDA CROCKETT LINGLE, Mayor, County of Maui and the COUNTY OF MAUI (collectively MAUI COUNTY), by and through their attorneys, filed a motion to dismiss with the Hawaii Labor Relations Board (Board). MAUI COUNTY's counsel states in an affidavit attached to the motion that the parties agreed to dismiss these complaints and to request the Board to issue another list of five arbitrators. MAUI COUNTY's counsel further states

that the parties agreed that any decision rendered by Arbitrator Randall Ching shall not be binding on the newly-selected arbitrator. However, the parties shall be provided the opportunity to present arguments concerning the applicability of any decision of Arbitrator. Accordingly, MAUI COUNTY requested that the Board issue an order dismissing the instant complaints and that such order contain the terms of the parties' agreement as expressed at the hearing held on September 25, 1997.


On that date, the parties represented to the Board that they agreed to withdraw the instant prohibited practice complaints and to request the Board to submit another list of five arbitrators. The parties also agreed that the Board would retain jurisdiction to enforce compliance with previous orders entered in this case.

The HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO and FRANCIS INO has not filed a response to MAUI COUNTY'S motion to dismiss.

Accordingly based on the foregoing, the Board hereby grants MAUI COUNTY'S motion to dismiss the instant complaints. Either party may request the Board to issue a new list of arbitrators.


