ORDER GRANTING RESPONDENT'S AMENDED
MOTION TO CONTINUE HEARING; NOTICE OF HEARING

On April 8, 1998, Complainant KEITH J. KOHL (KOHL) filed a motion to continue/dismiss without prejudice to resubmit with the Hawaii Labor Relations Board (Board).

Thereafter, on April 9, 1998, Respondent JAMES TAKUSHI, Director, Department of Human Resources Development, State of Hawaii (TAKUSHI), by and through his attorneys, filed a motion to continue hearing with the Board. On April 13, 1998, Respondent TAKUSHI, by and through his attorneys, filed an amended motion to continue hearing with the Board. TAKUSHI requested a continuance of the hearing previously scheduled on April 23, 1998 at 9:00 a.m., on Respondent RUSSELL OKATA, Executive Director, Hawaii Government Employees Association, AFSCME, LOCAL 152, AFL-CIO (OKATA)'s dispositive motion, i.e., motion to dismiss prohibited practice


complaint, until May 8, 1998. TAKUSHI's counsel states in an affidavit submitted in support of the motion that he has a conflict in his schedule with the hearing as presently scheduled. TAKUSHI's counsel further states that he contacted the other parties to the proceedings and neither party objected to the continuance.

Based on the foregoing, the Board hereby grants TAKUSHI's amended motion to continue hearing.

YOU ARE HEREBY NOTIFIED that the Board will hear OKATA's motion to dismiss prohibited practice complaint and also, KOHL's motion to continue/dismiss on May 8, 1998 at 9:00 a.m., in the Board's hearings room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.
