

Kusaka (Kusaka), Mayor of the County of Kauai, by and through her counsel, filed a motion to withdraw her motion for joinder in Linda Lingle, Mayor, County of Maui's Prohibited Practice Complaint filed on June 17, 1998 with the Hawaii Labor Relations Board (Board). Kusaka seeks to withdraw the joinder on the grounds that the motion was improperly filed.


