AND/OR FOR SUMMARY JUDGMENT; NOTICE OF RESCHEDULED HEARING

On May 1, 2000, Respondent RUSSELL OKATA, Executive Director, Hawaii Government Employees Association, AFSCME, LOCAL 152, AFL-CIO (OKATA), by and through his counsel, filed a motion to continue the hearing on Respondent JAMES TAKUSHI's motion to dismiss and/or for summary judgment scheduled for hearing on May 16, 2000 at 9:30 a.m. with the Hawaii Labor Relations Board (Board). Respondent OKATA's counsel states in a declaration filed in support of the motion that he is unable to attend the hearing due to an arbitration scheduled on April 15, 2000. Respondent's counsel further states that counsel for Respondent TAKUSHI agreed to continue the hearing to May 18, or May 24, 25, or 26, 2000. Respondent's counsel did not contact Complainant.

Based on the foregoing, the Board hereby grants Respondent's motion to continue the hearing on Respondent TAKUSHI's motion to dismiss and/or for summary judgment.




