On September 12, 2000, the UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its representative, filed a written notification to the Hawaii Labor Relations Board (Board) that an impasse had been reached in contract negotiations for employees in bargaining unit 10. The UPW requested that the Board issue a declaration of impasse and appoint a mediator.

The Board hereby acknowledges receipt of UPW's notification that an impasse exists in contract negotiations for bargaining unit 10.


