ORDER GRANTING RESPONDENTS' MOTIONS TO EXTEND TIME TO
FILE RESPONSES TO COMPLAINANTS' MOTION FOR SUMMARY JUDGMENT

On July 13, 2001, Complainants (Unions) filed a Motion for Summary Judgment with the Hawaii Labor Relations Board (Board). Thereafter, on July 18, 2001, Respondent THOMAS DRISKILL, CEO, HAWAII HEALTH SYSTEMS CORPORATION, Department of Health, State of Hawaii (HHSC), by and through his counsel, filed a motion to enlarge the time to file an opposition to Complainants' motion. Respondent HHSC's counsel states in an affidavit filed in support of the motion that the HHSC's lead counsel is currently on the mainland and will not be returning until August 1, 2001. Respondent HHSC's counsel further states that opposing counsel does not object to an extension of time until August 3, 2001 to file an opposition to Complainants' motion.

Also on July 18, 2001, Respondents BENJAMIN J. CAYETANO, Governor, State of Hawaii and LAWRENCE MIIKE, M.D., Director, Department of Health, State of Hawaii (collectively State Respondents), by and through their counsel, filed a motion for extension of time in which to file a response to the Unions' motion for summary judgment with the Board. Counsel for State Respondents states in a supporting affidavit that due to her schedule she is unable to adequately prepare a response within the time frame prescribed by the Board's rules and requests an extension until August 3, 2001. Counsel for State

Respondents further states that the other parties do not object to her request for an extension of time.

For good cause shown, the Board hereby grants Respondents' motions to extend the time within which to respond to Complainants' motion for summary judgment until the close of business on August 3, 2001.
