On September 10, 2001, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) filed a motion to amend its complaint filed on February 5, 2001 with the Hawaii Labor Relations Board (Board) 2001. Complainant moved to amend its complaint to include allegations of specific violations by the above-named Respondents which have occurred since February 5, 2001. Thereafter, on September 25, 2001, the UPW filed a request that the Board grant its motion to amend complaint filed on September 10, 2001 in the absence of a timely opposition. Complainant contends that Respondents have not filed a timely opposition to its motion to amend its complaint and therefore the motion should be granted.

In the absence of any opposition to the instant motion, the Board, pursuant to Hawaii Administrative Rules § 12-42-43, hereby grants the UPW's motion to amend its complaint filed on February 5, 2001. The UPW shall forthwith file its First Amended Prohibited Practice Complaint with the Board. The Board will thereupon issue a Notice to Respondents of the First Amended Prohibited Practice Complaint and Respondents shall file a written answer to the amended complaint within ten days after service of the First Amended Prohibited Practice Complaint.


