ORDER GRANTING COMPLAINANT'S MOTION FOR EXTENSION OF TIME

In Order No. 2053 issued on January 22, 2002, the Hawaii Labor Relations Board (Board) granted Respondents' motions for particularization and directed Complainant to file the original and five copies of the Particularization of her Complaint, with proof of service upon Respondents, no later than 4:30 p.m. of the fifth working day after service of the Order.

On January 31, 2002, Complainant filed a motion for extension of Order No. 2053 with the Board. Complainant requested a 30-day extension to obtain legal counsel; because of time constraints with employment obligations; and limited local resources.

On February 1, 2002, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) filed an opposition to the instant motion. UPW contends that the motion does not comply with Hawaii Administrative Rules § 12-42-8(g)(3)(C) which requires motion to be accompanied by an affidavit which provides factual support for the motion. The UPW also contends that granting the motion would unduly delay a proper disposition of the complaint within 40 days of the filing of the complaint.

In considering the arguments raised, the Board finds in the interests of justice good cause to grant Complainant's motion as she seeks legal counsel. Complainant shall file her Particularization with the Board on or before March 11, 2002.
