ORDER GRANTING COMPLAINANT'S MOTION FOR  
CONTINUANCE OF HEARING; NOTICE OF RESCHEDULED HEARING

On May 8, 2002, Complainant HELEN L. GABRIEL (GABRIEL) filed a motion requesting the continuance of the hearing scheduled on May 10, 2002 to May 24, 2002 with the Hawaii Labor Relations Board (Board). GABRIEL states in an affidavit attached to the motion that, inter alia, that it would be a hardship to attend the hearing as scheduled. Also on that date, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) filed an opposition to Complainant's motion to continue the hearing scheduled on May 10, 2002 contending, inter alia, that GABRIEL lacks good cause to extend the hearing date because she is available to appear on that date and that other extensions have already been granted to Complainant.


After reviewing the record in this case and considering the arguments raised by the parties, the Board hereby grants Complainant's motion for continuance for good cause.
