




Consistent with the Board's previous rulings on subpoenas served on Jamile, Sasamura, Donahue, and OKUMA-SEPE where the UPW withdrew item #3 of the respective subpoena duces tecum, the Board denies Fukunaga's motion to revoke and/or quash the subpoena duces tecum. The Board further denies Lee's motion to revoke and/or quash the subpoena duces tecum because it is untimely in view of the deadline to file motions to revoke and/or quash subpoenas established at the prehearing conference held on May 20, 2002.
