ORDER APPOINTING A MEDIATOR

On July 1, 2002, the HAWAII FIRE FIGHTERS ASSOCIATION, IAFF LOCAL 1463, AFL-CIO, (HFFA), by and through its representative, filed a written notification to the Hawaii Labor Relations Board (Board) that it initiated negotiations over a collective bargaining agreement for employees in bargaining unit 11 (Firefighters) by letter dated January 31, 2002 and an impasse has been reached in contract negotiations. Pursuant to Hawaii Revised Statutes § 89-11(c), July 1, 2002 is the date of impasse.

To assist the parties, the Board has asked the Federal Mediation and Conciliation Service to provide a mediator to assist the parties in the voluntary resolution of their dispute. Federal Mediator Carol Catanzariti has agreed to serve and is hereby appointed as mediator in the instant impasse.


