ORDER GRANTING COMPLAINANT'S EX PARTE  
MOTION TO POSTPONE 11/27/02 HEARING; AND  
NOTICE OF RESCHEDULED PREHEARING CONFERENCE AND  
HEARING ON RESPONDENT CITY'S MOTION TO DISMISS COMPLAINT

On November 21, 2002, Complainant RICHARD GARCIA GONSALES II (GONSALES) filed an ex parte motion with Hawaii Labor Relations Board (Board) to postpone the prehearing conference presently scheduled on November 27, 2002 and the date on which his Prehearing Statement is due for one month. GONSALES requests the postponement in order to obtain an attorney. GONSALES states in a declaration attached to his motion that despite his diligence, he has been unable to retain counsel thus far.

Based on the foregoing and as Respondents' counsel do not object to the postponement, the Board hereby grants Complainant's motion.

NOTICE IS HEREBY GIVEN that the Board, pursuant to Hawaii Revised Statutes (HRS) § 89-5(b)(4) and HAR § 12-42-47, will conduct a prehearing conference on the above-entitled prohibited practice complaints on January 9, 2003 at 9:30 a.m. in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii. Complainant shall file his Prehearing Statement with the Board two days prior to the rescheduled prehearing conference.

NOTICE IS ALSO GIVEN that pursuant to HRS §§ 89-5(b)(4) and (5) and 89-14 and HAR § 12-42-8(g)(3), the Board will conduct a hearing on the CITY's motion to dismiss the complaint filed in Case No. CE-12-520 on January 9, 2003 immediately following the prehearing conference. GONSALES may file an answering affidavit in response to the CITY's motion with the Board, pursuant to HAR § 12-42-8(g)(3)(iii), by the close of business on January 7, 2003.

Appropriate provisions of the notice issued on November 15, 2002 remain applicable.
