HEARING: AND NOTICE OF SECOND PREHEARING CONFERENCE

On January 7, 2003, Respondent filed a motion with the Hawaii Labor Relations Board (Board) to continue the hearing on the merits of this case scheduled on January 15, 2003 at 9:30 a.m. Respondent's counsel states in a declaration attached to the motion that during the prehearing conference held on November 26, 2002, the Board required Respondent to file any dispositive motions by January 6, 2003 and scheduled a hearing on the merits of this case on January 15, 2003. Thereafter, Respondent's counsel was appointed as the Administrator for UPW/AFSCME and feels there may be a conflict of interest in representing Respondent. Respondent's counsel therefore requests a continuance of the previously established deadlines and a reasonable amount of time to obtain alternate legal representation in this case. Respondent's counsel further states that Complainant does not object to Respondent's motion for continuance.

Based on the foregoing, the Board hereby grants Respondent's motion to continue the hearing in this matter scheduled on January 15, 2003 to obtain alternate legal representation.
