## ORDER GRANTING PETITIONS FOR INTERVENTION: AND NOTICE OF PREHEARING CONFERENCE

On September 5, 2003, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA), COUNTY OF MAUI, DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT, State of Hawaii, BOARD OF REGENTS, University of Hawaii, COUNTY OF HAWAII, CITY AND COUNTY OF HONOLULU, and THOMAS R. Counsel for the COUNTY OF MAUI and COUNTY OF HAWAII, respectively, may request to participate in the prehearing conference by conference call by notifying the Board one day in advance of the conference.

All parties have the right to appear in person and to be represented by counsel or other representative.
