**ORDER GRANTING COMPLAINANT'S EX PARTE  
MOTION TO CONTINUE FILING OF PREHEARING STATEMENT,  
PREHEARING CONFERENCE, AND HEARING DATE, FILED ON  
MARCH 31, 2004; AND NOTICE OF RESCHEDULED PREHEARING CONFERENCE**

On March 31, 2004, Complainant, by and through its counsel, filed an ex parte motion with the Hawaii Labor Relations Board (Board) to continue: the filing of the prehearing statement until April 23, 2004, the prehearing conference presently scheduled on April 8, 2004 to April 28, 2004 at 9:30 a.m. and the hearing date presently scheduled on April 28, 2004 to approximately May 17, 2004. Complainant's counsel states in an affidavit attached to the motion that the Hawaii County Police Commission has a meeting scheduled on April 16, 2004 which should involve the matters of the instant case and there is a good likelihood that the parties may be able to resolve the underlying dispute without the need for a hearing. Complainant's counsel further states that opposing counsel consents to the continuances.

Based on the foregoing, the Board hereby grants Complainant's motion. Pursuant to their agreement, the parties shall file their respective Prehearing Statements with the Board by the close of business on April 23, 2004. The hearing on the merits of the case will be rescheduled at a later date.

NOTICE IS HEREBY GIVEN that the Board, pursuant to HRS §§ 89-5(i)(4) and (i)(5) and Hawaii Administrative Rules (HAR) § 12-42-47, will conduct a prehearing conference on the above-entitled prohibited practice complaint on April 28, 2004 at 9:30 a.m. by conference call. Respondent's counsel will be contacted at his telephone number on file with the Board. Complainant's counsel shall appear in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii at the designated time.
