ORDER GRANTING COMPLAINANT'S MOTION  
TO AMEND COMPLAINT, FILED ON MAY 13, 2004 AND  
COMPLAINANT'S MOTION TO CONTINUE HEARING, FILED ON MAY 13, 2004

At the prehearing conference held in this matter on May 10, 2004, the parties agreed that the case was suited for summary disposition. Complainant was permitted to file a motion to amend the complaint by May 14, 2004 with a hearing on the motion to be held on May 17, 2004, if appropriate. The Board also set June 9, 2004 as the deadline for the filing of cross motions for summary judgment and scheduled a hearing on the motions on June 18, 2004.

On May 13, 2004, Complainant filed a Motion to Amend Complaint and a Motion to Continue Hearing with the Hawaii Labor Relations Board (Board). Complainant contends that the complaint should be amended to clarify the nature of the claims for relief and amplify on its theory of the case as well as to supplement its pleading based on developments occurring subsequent to the filing of the complaint in this matter. Complainant also filed motion to continue the hearing previously scheduled on the merits of the complaint on May 17, 2004 in the event the dispositive motions are denied.

For good cause shown and Respondent having no objection thereto, the Board hereby grants Complainant's Motion to Amend the Complaint pursuant to Hawaii Administrative Rules § 12-42-43. Complainant shall forthwith file its First Amended Prohibited Practice Complaint with the Board. The Board will thereupon issue a Notice to Respondent of the First Amended Prohibited Practice Complaint and Respondent shall file

a written answer to the amended complaint within ten days after service of the First Amended Prohibited Practice Complaint.

For good cause shown and Respondent having no objection thereto, the Board also grants Complainant's motion to continue the hearing previously scheduled on May 17, 2004.
