ORDER CONSOLIDATING CASES FOR DISPOSITION AND ORDER APPOINTING CHAIR OF ARBITRATION PANEL AND CERTIFYING APPOINTMENT OF THE PANEL

On December 20, 2004, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA), by its representative, submitted a letter to the Hawaii Labor Relations Board (Board) indicating that the parties have agreed to an alternate impasse procedure pursuant to Hawaii Revised Statutes § 89-11(a) and to engage Thomas Angelo as the Chair of the interest arbitration panel for bargaining units 02, 03, 04, 06, 08, and 13.

Based on the foregoing, the Board finds that these cases involve substantially the same parties and issues and consolidation of the cases would be conducive to the proper dispatch of business and the ends of justice and will not unduly delay the proceedings. Pursuant to Hawaii Administrative Rules (HAR) § 12-42-8(g)(13), the Board hereby consolidates Case Nos. I-02-105a, I-03-105b, I-04-105c, and I-13-105d with Case Nos. I-06-106 and I-08-107 and the proceedings thereon for disposition.

Moreover, as the parties have selected Thomas Angelo to serve as the impartial arbitrator and chair of the panel to which they shall submit their complete final offers as provided in HRS § 89-11(e), as modified by their mutually agreed upon arbitration procedure. In addition, the above-named Exclusive Representative has selected Lawrence Ishimi to serve on the panel and the Employers have selected Georgina Kawamura to serve on the panel.

Accordingly, the Board hereby appoints Thomas Angelo as the impartial member and chair of the arbitration panel and certifies Lawrence Ishimi and Georgina Kawamura as members of the panel. The panel shall have such authority and duties as conferred by law.
