By letter dated March 10, 2006, Complainant requested the Hawaii Labor Relations Board (Board) to grant two-month continuance of the case to obtain legal representation. On March 16, 2006, Respondent filed an Opposition to Complainant Struba's Motion for a Two Month Continuance of the March 24, 2006 Hearing with the Board. Respondent contends that Complainant failed to timely respond to its February 23, 2006 motion to dismiss as required by the Board's Administrative Rules §12-42-8(g)(3)(C)(iii). Respondent also contends that in accordance with applicable rules, the Board is obligated to conduct a hearing on a prohibited practice complaint within 40 days after filing and a twomonth continuance is simply too long.

After considering the record and the arguments presented, the Board finds good cause to continue the hearing to permit Complainant to obtain legal counsel and prepare his position. The Board therefore hereby grants Complainant's request for a two-month continuance of the hearing on Respondent's Motion to Dismiss and/or for Summary Judgment filed on February 23, 2006.

NOTICE IS HEREBY GIVEN that the hearing on Complainant's Motion to Dismiss and/or for Summary Judgment filed on February 23, 2006 previously scheduled on March 24, 2006 at 9:30 a.m. is rescheduled on May 24, 2006 at 9:30 a.m. in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.
