ORDER DECLARING IMPASSE

On August 21, 2006, the HAWAII FIRE FIGHTERS ASSOCIATION, LOCAL 1463, IAFF, AFL-CIO ("HFFA"), by and through its representative, filed a notice with the Hawaii Labor Relations Board ("Board") pursuant to Hawaii Revised Statutes ("HRS") § 89-11(e) stating that an impasse exists with respect to negotiations for bargaining unit 11. The HFFA also notified the Board that the parties have agreed to an alternative impasse procedure ("Impasse Procedure") pursuant to HRS § 89-11(a). The Impasse Procedure provides that the parties may at any time request the assistance from the Federal Mediation and Conciliation Service to assist the parties.

Pursuant to HRS § 89-11(c), the Board hereby declares that an impasse exists in negotiations for bargaining unit 11 as of August 21, 2006.
