ORDER DECLARING AN IMPASSE AND APPOINTING A MEDIATOR

On September 15, 2006, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO ("HGEA"), by and through its representative, filed a written notification with the Hawaii Labor Relations Board ("Board") that negotiations over a collective bargaining agreement for employees in bargaining unit 09 (Registered professional nurses) commenced on May 10, 2006 and an impasse has been reached in contract negotiations. Pursuant to Hawaii Revised Statutes § 89-11(c), September 15, 2006 is the date of impasse.

To assist the parties, the Board has asked the Federal Mediation and Conciliation Service to provide a mediator to assist the parties in the voluntary resolution of their dispute. Federal Mediator Ken Kawamoto has agreed to serve and is hereby appointed as mediator in the instant impasse.
