On January 22, 2007, Complainant, by and through its counsel, filed an Ex Parte Motion to Extend Time in Which to File a Motion to Amend Prohibited Practice Complaint and to Extend the Time in Which to Respond to HHSC's Motion Filed Herein on January 16, 2007, with the Hawaii Labor Relations Board ("Board"). Complainant's counsel states in an affidavit attached to the motion that due to illness he was unable to file a motion to amend the instant complaint by the January 16, 2007 deadline stipulated to by the parties in this case. In addition, Complainant's counsel states that he is also unable to respond to the HHSC's Motion for Judgment as a Matter of Law, filed with the Board on January 16, 2007 in the normal course, on January 23, 2007. Complainant thus requests an extension until January 26, 2007 to file any motion and response to the HHSC's Motion for Judgment as a Matter of Law.

Based on the foregoing, the Board hereby grants the instant ex parte motion for good cause shown. Complainant shall file any motion to amend the instant prohibited practice complaint and response to HHSC's Motion for Judgment as a Matter of Law by the close of business on January 26, 2007.
