ORDER GRANTING PETITIONS FOR INTERVENTION

On March 21, 2007, the Hawaii Labor Relations Board (“Board”) issued a Notice of Filing of First Amended Petition for Declaratory Ruling; Notice of Deadline for Filing of Petitions for Intervention; and Briefing Schedule; First Amended Petition for Declaratory Ruling setting April 9, 2007 as the deadline to file petitions for intervention in this proceeding. On April 9, 2007, the UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (“UHPA”) and the COUNTY OF HAWAII (“Hawaii County”), by and through their respective counsel, filed petitions for intervention with the Board. UHPA also filed a Position Statement as requested by the Board.

After reviewing the petitions filed, the Board finds that UHPA, as the exclusive representative of Unit 07 and Hawaii County, as a public employer, have interests which could be affected by a ruling in this case. Based on the foregoing, the Board finds that UHPA and Hawaii County filed timely Petitions for Intervention and have alleged sufficient interests to intervene in this case. Accordingly, the Board grants the instant petitions for intervention pursuant to Hawaii Administrative Rules (“HAR”) §§ 12-42-8(g)(14) and 12-42-9(e).

In accordance with the briefing schedule established in this case, Petitioner UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO filed its memorandum in support of its petition on April 23, 2007. Intervenors may file a responsive brief or

memoranda with the Board by the close of business on May 7, 2007. Any reply by Petitioner is due on May 14, 2007.
