ORDER APPROVING STIPULATIONS AND CLOSING INVESTIGATION

ORDER APPROVING STIPULATIONS AND CLOSING INVESTIGATION

On March 10, 2005, the County of Hawaii filed a Stipulation Re Bargaining Unit Status with the Hawaii Labor Relations Board ("Board"). On April 1, 2005, RONALD T.Y. MOON, by and through his counsel, filed a Stipulation Between the Hawai'i Government Employees Association and Ronald T.Y. Moon, Chief Justice, State of Hawai'i with the Board. Also on April 1, 2005, Lynn G. Krieg, Director of Personnel Services, County of Maui filed a Stipulation between Maui County and the HAWAII FIRE FIGHTERS ASSOCIATION ("HFFA"), as well as a List of Excluded Positions. On April 15, 2005, MARYANNE KUSAKA, by and through her counsel, filed a Stipulation Regarding Excluded Positions with the Board regarding the HFFA, the STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS, and the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION ("HGEA") positions. Thereafter, on

May 4, 2005, the BOARD OF REGENTS, University of Hawaii, by and through its counsel, filed a Stipulation Between the Board of Regents, University of Hawai'i and University of Hawai'i Professional Assembly with the Board. On May 6, 2005, the BOARD OF REGENTS, by and through its counsel filed a Stipulation Between the Board of Regents and the Hawai'i Government Employees Association with the Board. On June 1, 2005, JEREMY HARRIS, by and through his counsel filed a Stipulation Regarding Bargaining Unit Status with the HFFA and a List of Excluded Positions with the Board. On June 28, 2005, BENJAMIN J. CAYETANO, by and through his representative, filed a Stipulation Regarding Bargaining Unit Status regarding Unit 11 exclusions with the Board.

After reviewing the foregoing Stipulations, the Board hereby approves the Stipulations between the parties. The Board also notes that the Stipulations for the State of Hawaii, City and County of Honolulu, and the County of Maui do not include stipulations for the exclusion of positions with the HGEA. The Board encourages the parties to continue to work to consensus with the applicable exclusive bargaining representatives on the bargaining unit exclusions to resolve any disputes or to seek clarification of the bargaining unit pursuant to Hawaii Revised Statutes § 89-6 and Hawaii Administrative Rules § 12-42-20, as applicable.

Accordingly, the Board hereby closes this investigation.
