ORDER GRANTING PETITIONS FOR INTERVENTION


On September 17, 2007, the Hawaii Labor Relations Board (Board) issued a Notice of Filing of Petition for Declaratory Ruling; Notice of Deadline for Filing of Petitions for Intervention; and Notice of Board Conference setting October 3, 2007 as the deadline for interested persons to file petitions for intervention in this proceeding. On September 27, 2007, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO, by and through its counsel, filed a petition for intervention with the Board. Also on October 2, 2007, CLAYTON A. FRANK (FRANK), Director, Department of Public Safety (PSD), State of Hawaii, and on October 3, 2007, HARRY KIM (KIM), Mayor, County of Hawaii, by and through their counsel, filed their respective petitions for intervention with the Board.

After reviewing the petitions filed, the Board finds that HGEA, as the exclusive representative of Units 02, 03, 04, 06, 08, 9, and 13, and FRANK, the Director of the PSD, and KIM, Mayor of the County of Hawaii, as public employers, have interests which could be affected by a ruling in this case. Based on the foregoing, the Board finds that the HGEA, FRANK, and KIM filed timely Petitions for Intervention and have alleged sufficient interests to intervene in this case. Accordingly, the Board grants the instant petitions for intervention pursuant to Hawaii Administrative Rules (HAR) §§ 12-42-8(g)(14) and 12-42-9(e).
