
On November 7, 2007, Complainant DEPARTMENT OF PUBLIC SAFETY, State of Hawaii (PSD), by and through its counsel, filed a Motion for Summary Judgment with the Hawaii Labor Relations Board (Board). On November 8, 2007, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW), by and through its counsel, filed the instant motion to extend the deadline to file an opposition to Complainant's motion until five business days following the Board's ruling on a pending motion to defer to circuit court's final judgment and/or for dismissal of complaint filed on October 15, 2007. UPW's counsel states in an affidavit attached to the motion that on November 6, 2007, the Board heard oral argument on the UPW's motion to defer to the circuit court's final judgment and/or for dismissal of the complaint which the Board took under advisement pending a written ruling. UPW's counsel further states that under applicable Board rules, UPW's response to PSD's motion for summary judgment is due on November 15, 2007. Since the Board's ruling may dispose of the case or affect what issues remain in the proceeding, UPW's counsel requested an extension to file an opposition in order to avoid unnecessary costs and expenditure.

For good cause shown, the Board hereby grants UPW's the deadline to file an opposition to Complainant's motion until five business days following the Board's ruling on the UPW's pending motion to defer to circuit court's final judgment and/or for dismissal of complaint filed on October 15, 2007.
