
ORDER GRANTING HFFA/IAFF'S MOTION TO WITHDRAW
PROHIBITED PRACTICE COMPLAINT FILED ON SEPTEMBER 21, 2007

On September 21, 2007, Complainant HAWAII FIRE FIGHTERS ASSOCIATION, IAFF, LOCAL 1463, AFL-CIO (HFFA/IAFF) filed the instant prohibited practice complaint against the above-named Respondents with the Hawaii Labor Relations Board (Board). Thereafter, on January 14, 2008, the HFFA/IAFF, by and through its counsel, filed a motion to withdraw its Prohibited Practice Complaint because the parties have satisfactorily resolved the dispute underlying the current prohibited practice complaint.

Hawaii Administrative Rules (HAR) § 12-42-44 provides that a complaint can be withdrawn at any time prior to the issuance of a final decision and order upon motion and with the consent of the Board. Based upon the foregoing and a review of the HFFA/IAFF's motion, the Board hereby grants Complainant's motion to withdraw the instant complaint.
