On October 5, 2007, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA), by and through its counsel, filed a motion with the Hawaii Labor Relations Board (Board) to withdraw the Second Amended Prohibited Practice Complaint filed on November 28, 1997, and to the extent necessary, the claims in the Prohibited Practice Complaint filed on July 15, 2997 and the First Amended Prohibited Practice Complaint filed on November 19, 1997, as to claims made by the HGEA. The HGEA submits that it no longer wishes to pursue these claims and seeks to withdraw the Second Amended Prohibited Practice Complaint and be dismissed from the case. HGEA's counsel Lisa Anne Gruebner states in a Declaration filed in support of the motion that the withdrawal of HGEA's claims will not prejudice any party remaining in the case.

Based on the foregoing, the Board grants the HGEA's motion to withdraw the Second Amended Prohibited Practice Complaint filed on November 28, 1997 as well as its claims in the Prohibited Practice Complaint filed on July 15, 1997 and the First Amended Prohibited Practice Complaint filed on November 19, 1997.
