On April 10, 2008, Intervenor LINDA LINGLE, Governor, State of Hawaii, by and through her counsel, filed a Motion to Dismiss Petition for Declaratory Ruling with the Hawaii Labor Relations Board (Board). Thereafter on April 30, 2008, Intervenor Battalion Chiefs, by and through their counsel, filed a Joinder in Intervenor Linda Lingle, Governor, State of Hawaii's Motion to Dismiss Petition for Declaratory Ruling as well as a Motion to Dismiss Petition for Declaratory Ruling Filed March 11, 2008 with the Board.

On May 5, 2008, Complainant HAWAII FIRE FIGHTERS ASSOCIATION, IAFF, LOCAL 1463, AFL-CIO (HFFA/IAFF) filed a motion to withdraw the instant petition for declaratory ruling with the Board due to rulings and stipulations made during a Civil Service Commission hearing on April 29, 2008. Complainant's counsel stated in a declaration filed in support of the motion that he has been authorized to withdraw the instant petition in lieu of submitting any memoranda in opposition to the two pending motions to dismiss.

Based upon the foregoing and a review of the record, the Board hereby grants the HFFA/IAFF's motion to withdraw the instant petition for declaratory ruling.
