Thereafter on April 30, 2008, Intervenor Battalion Chiefs, by and through their counsel, filed a Joinder in Intervenor Linda Lingle, Governor, State of Hawaii's Motion to Dismiss Petition for Declaratory Ruling as well as a Motion to Dismiss Petition for Declaratory Ruling Filed March 11, 2008 with the Board.

On May 5, 2008, Complainant HAWAII FIRE FIGHTERS ASSOCIATION, IAFF, LOCAL 1463, AFL-CIO (HFFA/IAFF) filed a motion to withdraw the instant petition for declaratory ruling with the Board due to rulings and stipulations made during a Civil Service Commission hearing on April 29, 2008.
