ORDER GRANTING HSTA'S MOTION TO CONTINUE HEARING
AND TO EXTEND THE DEADLINE TO FILE HSTA'S OPPOSITION

On April 10, 2008, the Hawaii Labor Relations Board (Board) conducted a prehearing/settlement conference in this matter where the parties agreed to take the scheduled April 22, 2008 hearing off of the calendar. The Board set May 12, 2008 as the deadline for the Complainant HAWAII STATE TEACHERS ASSOCIATION (HSTA) to file its memorandum in opposition to Respondents' Motion to Dismiss or in the Alternative, for Judgment on the Pleadings filed on April 8, 2008. Respondents' reply was due on May 19, 2008 and the hearing on the motion was scheduled on May 21, 2008 at 9:00 a.m.


On April 28, 2008, the HSTA, by and through its counsel, filed a Motion to Continue Hearing and to Extend Deadline on Respondents' Motion to Dismiss and HSTA's Opposition with the Board. The HSTA moved to extend the May 12, 2008 deadline for HSTA's opposition to Respondents' motion to dismiss to July 3, 2008 and to continue the May 21, 2008 hearing date to July 9, 2008 in order to review the statements made by Respondents' counsel at the prehearing conference.

Respondents took no position as to the HSTA's motion to continue. Based on the foregoing and a review of the record in this case, the Board hereby grants the HSTA's motion to continue the briefing deadlines and the hearing on the foregoing


motion. However, in order to preserve the time sequence previously established, the deadline for HSTA's opposition to the Respondents' Motion to Dismiss, or in the Alternative, for Judgment on the Pleadings is July 3, 2008. Respondents' reply is due on July 11, 2008 and the hearing on the motion is scheduled on July 17, 2008 at 9:00 a.m. in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii 96813.
