MOTION FOR TEMPORARY RESTRAINING ORDER, FILED ON JULY 11, 2008

On July 17, 2008, Complainant UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (UHPA), by and through its counsel, filed a Motion for Leave to Amend Complaint with the Hawaii Labor Relations Board (Board.). UHPA seeks to amend its complaint by citing statutory violations of Hawaii Revised Statutes (HRS) §§ 89-9 and 89-13(a)(7) and (8), in addition to the HRS § 89-13(a)(5) allegation in its original complaint filed with the Board. UHPA contends that the additional statutory citations provide a more comprehensive basis for the complaint without expanding upon the facts and circumstances underlying the alleged violations. Respondents did not oppose the amendment of the complaint.

After reviewing the record and the instant motion, the Board, in its discretion, hereby grants UHPA's motion to amend its complaint pursuant to Hawaii Administrative Rules § 12-42-43.¹

Complainant shall forthwith file its First Amended Prohibited Practice Complaint with the Board. The Board will thereupon issue a Notice to Respondents of the First Amended Prohibited Practice Complaint.


¹Hawaii Administrative Rules § 12-42-43 provides as follows:

Any complaint may be amended in the discretion of the board at any time prior to the issuance of a final order thereon.
