Complainant's counsel attached a letter, dated September 29, 2008, to the motion, from Donna Ikeda, Chairperson, BOE and PATRICIA HAMAMOTO, Superintendent, Department of Education, requesting Mark J Bennett, Attorney General, to remove them as Complainants in this matter.


