## ORDER GRANTING PETITION FOR INTERVENTION

8. 2008, Petitioner UNIVERSITY On October OF **HAWAII** PROFESSIONAL ASSEMBLY (Petitioner or UHPA), by and through its counsel, filed a Petition for Clarification or Amendment of Appropriate Bargaining Unit (Petition) with the Hawaii Labor Relations Board (Board). Petitioner requested bargaining unit clarification of six positions which allegedly perform Unit 07 Faculty Librarian work but which are included in Unit 08, Personnel of the University of Hawaii and the community college system, other than faculty. UHPA contended that based on the duties and qualification of 2 Educational Specialists which are currently filled, 2 Instructional Support Specialists, 1 Metadata Specialist and 1 Inter-Library Loan (ILL) Acquisition Specialist, that the positions should properly be included in Unit 07. On October 10, 2008, the Board issued a Notice of Filing of Petition for Declaratory Ruling; Notice of Deadline for Filing Petitions for Intervention; and Notice of Board Conference which set October 28, 2008 as the deadline to file any petitions for intervention.

On October 28, 2008, the BOARD OF REGENTS, University of Hawaii (BOR), by and through its counsel, filed a Petition for Intervention with the Board in this matter. The BOR alleges that it is a public employer under the Hawaii Revised Statutes (HRS) of Units 07 and 08 and any decision rendered in this proceeding will affect its rights and interest in managing University affairs. The BOR alleges that its intervention in this proceeding will contribute to the development of a sound record.

Based on the record and a review of the instant timely Petition for Intervention, the Board finds that the BOR is the public employer of the instant positions

and that its interests may be impacted by a Board decision in this case sufficient to warrant its intervention. Accordingly, the Board grants the BOR's Petition for Intervention pursuant to Hawaii Administrative Rules (HAR) §§ 12-42-8(g)(14) and 12-42-9(e).
