On February 9, 2009, Complainant HAWAII STATE TEACHERS ASSOCIATION (HSTA), by and through its counsel, filed a Motion to Continue Hearing Dates with the Hawaii Labor Relations Board (Board.). The HSTA requests that the hearing scheduled to start on February 23, 2009 be continued to other mutually agreeable to dates or alternatively, to start the hearing on February 24, 2009 and reschedule the hearing dates of February 23 and 25, 2009 because of conflicts in Complainant's counsel's schedule.


By letter dated February 11, 2009, Respondents' counsel stated that he did not object to the continuance of the hearing and that he believed both parties preferred to continue the hearing dates rather than start on February 24, 2009.

Based on a review of the record, the Board hereby grants the continuance of the February 23 and 25, 2009 dates to accommodate Complainant's counsel's schedule.
