On March 2, 2009, Complainant filed a Motion to Withdraw Complaint without Prejudice with the Hawaii Labor Relations Board (Board.) Complainant moved to withdraw the instant complaint without prejudice pursuant to Hawaii Administrative Rules (HAR) § 12-42-44<sup>1</sup> and in accordance with the Joint Stipulation to Dismiss Without Prejudice Case No. CE-07-688 (Stipulation to Dismiss) entered into between the parties. The Board notes that the parties agreed to dismiss this case without prejudice and Respondent further agreed to withdraw Respondent's Motion for Summary Judgment, filed on February 23, 2009.

In accordance with the Stipulation to Dismiss, Respondent's Motion for Summary Judgment, filed on February 23, 2009 is deemed withdrawn. Based upon the foregoing and a review of the record, the Board hereby grants Complainant's motion to withdraw the instant complaint without prejudice.

<sup>1</sup>HAR § 12-42-44 provides for the Withdrawal of prohibited practice complaints and states as follows:

Any complaint may be withdrawn at any time prior to the issuance of a final order thereon, upon motion and with the consent of the board. Whenever the board approves withdrawal of such complaint, the case shall be closed.
