ORDER CLARIFYING ORDER NO. 230

On February 27, 1979, the Hawaii Government Employees' Association (hereafter HGEA) filed a Motion for Reconsideration in Case Nos. RA-03-11, RA-04-12, and RA-13-13.

Along with said motion, the HGEA filed a motion requesting permission to intervene in Case Nos. DR-03-34, DR-04-34, and DR-13-34 and asking that its aforesaid Motion for Reconsideration be "consolidated for hearing" with Case Nos. DR-03-34, DR-04-34, and DR-13-34.

By Order No. 230, this Board granted the HGEA's motion to intervene and stated, in pertinent part, respecting the HGEA Motion to Reconsider in Case Nos. RA-13-11, RA-04-12, and RA-13-13:

[T]he HGEA's Motion will be treated as having been made as part of Case Nos. DR-03-34, DR-04-34, and DR-13-34 and will be considered during the proceedings in said cases. (Emphasis added)

The language underscored in the quote from Order No. 230 inaccurately reflects the HGEA's request and the Board's intention and accordingly is, upon the Board's own motion, hereby rescinded.

The HGEA's Motion for Reconsideration in Case Nos. RA-03-11, RA-04-12, and RA-13-13 will not be treated as having been made as part of Case Nos. DR-03-34, DR-04-34, and DR-13-34. It is regarded as what it is in fact---a motion made in Case Nos. RA-03-11, RA-04-12, and RA-13-13.
