On May 29, 2009, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (HGEA/AFSCME), by and through its counsel, filed a Motion to Withdraw Prohibited Practice Complaint Filed on October 23, 2008 (Motion to Withdraw) with the Hawaii Labor Relations Board (Board). Complainant's counsel's declaration states that on May 27, 2009, counsel was informed by his client that Respondents had agreed not to implement the 20-hour limitation on special duty which was the subject of the instant complaint.
