On May 6, 2010, Respondent BOARD OF REGENTS, University of Hawaii (BOR), filed an Ex-Parte Motion to Extend Time to Answer or Otherwise Respond to Complaint Filed on April 27, 2010 with the Hawaii Labor Relations Board (Board). Respondent's counsel states in a Declaration attached to the motion that the deadline to answer to the instant Complaint filed on April 27, 2010, is May 9, 2010<sup>1</sup> and the parties are currently engaged in settlement discussions with regards to the matter which is the subject of the instant complaint and it is likely that the parties will reach a resolution. Respondent's counsel also states that Complainant's counsel is agreeable to extend the time for the BOR to answer and does not object to an extension of time of three weeks within which to answer or respond to the complaint.

Based on the foregoing, the Board hereby grants the BOR's ex parte motion to extend the time to respond to the instant Complaint, for good cause shown. The deadline for the BOR's response is June 1, 2010.


