ORDER GRANTING COMPLAINANT'S MOTION

On July 12, 2010, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW) filed a Motion to Approve Settlement (Motion) with the Hawaii Labor Relations Board (Board). The UPW requested the Board to approve a settlement entered into in this case as proposed during a prehearing conference held before the Board on June 15, 2010 by UPW's counsel and accepted by Respondents' counsel. UPW's counsel states, in part, in an affidavit filed in support of the Motion, that at the prehearing conference, the UPW proposed to resolve the issues on remand by an agreement rendering Order No. 2653 final and binding on the parties with no appeal to be taken from the court's May 4, 2010 decision and order affirming the order; that on July 8, 2010, UPW's counsel was informed by Respondents' counsel that the proposal was accepted by his client; and on July 10, 2010, UPW's counsel sent a letter confirming in writing the terms of the resolution.

Hearing no objection from Respondents, the Board hereby grants Complainant's Motion to Approve Settlement, filed on July 12, 2010. The Board appreciates the efforts of the parties to resolve the issues presented.
