## ORDER APPROVING R. STEVEN GESHELL'S MOTION TO WITHDRAW AS ATTORNEY FOR COMPLAINANT, FILED ON SEPTEMBER 16, 2010 AND NOTICE OF HEARING

On September 16, 2010, counsel for Complainant, R. Steven Geshell (Geshell), filed a Motion to Withdraw as Attorney for Complainant (Motion to Withdraw) with the Hawaii Labor Relations Board (Board). Complainant's counsel states in a Declaration, dated September 15, 2010, filed in support of the Motion to Withdraw that he received a letter from his client on September 15, 2010, telling him that she wants him to disassociate himself from the case and she would handle the case from this point on, and if needed, would contact another attorney whose prime focus is labor issues; that he considered his client's letter as discharging him as her attorney, and he therefore moved to withdraw from representing her in this case.

Hearing no opposition from Complainant or counsel for Respondent HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO's (HGEA) counsel, who were served with the instant motion, the Board hereby grants Geshell's Motion to Withdraw.

## NOTICE OF HEARING

Previously, on September 23, 2009, the Board issued Order No. 2639 in this matter, Order Approving Stipulation to Continue Hearing Pending Final Decision on Complainant's Appeal Before the Hawaii Appellate Courts, continuing the hearing on the

merits of this case pending the resolution of Case No. 29941 before the Intermediate Court of Appeals of the State of Hawaii. On September 22, 2010, the court filed a Stipulation for Dismissal with Prejudice of the Appeal Order in Case No. 29941.
