ORDER GRANTING UPW'S MOTION TO EXTEND DEADLINE
TO FILE OPPOSITIONS TO MOTIONS TO DISMISS AND/OR FOR
SUMMARY JUDGMENT; AND NOTICE OF HEARING ON MOTIONS

On October 26, 2010, Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (UPW or Union), by and through its counsel, filed a Motion to Clarify and to Extend Deadlines for Its Opposition to Motions to Dismiss and/or for Summary Judgment with the Hawaii Labor Relations Board (Board). In its motion, the UPW seeks clarification of Hawaii Administrative Rules § 12-42-8(c) and (g)(3)(C)(iii) and for an extension of deadlines for the Union to file its oppositions to the motions to dismiss and/or for summary judgment filed on October 21, 2010 by the State of Hawaii, BOARD OF EDUCATION and KATHRYN MATAYOSHI, the motion to dismiss and/or for summary judgment filed on October 25, 2010 by the LOCAL SCHOOL BOARD and DOUGLAS M. DOI, and a motion to dismiss and/or for summary judgment filed on October 25, 2010 by CHRISTINE SORENSON and the BOARD OF REGENTS, University of Hawaii. The Union requested a hearing date for the motions on

or after November 10, 2010 and a due date for the Union's opposition for November 9, 2010. UPW's counsel states in an affidavit filed in support of its motion, inter alia, that he currently has briefing deadlines and hearings for each day from October 27, 2010 through November 8, 2010 in other cases and is unavailable until November 9, 2010 to respond to the pending motions; that he understands that the Board's first available date for hearings after November 8, 2010 is November 9 and 10 (in the afternoon), 2010; and thus counsel requests an extension of the filing deadlines to November 9, 2010 or one day prior to the date the Board schedules the pending motions on November 10, 2010.

Based on the foregoing, the Board hereby grants the UPW's request for an extension of time to file its responses to the foregoing motions by the close of business on November 9, 2010. In its discretion, the Board also extends the deadline for the other parties to respond to the foregoing motions by November 9, 2010.


NOTICE IS HEREBY GIVEN that the Board, pursuant to HRS §§ 89-5(i)(4) and (i)(5) and HAR § 12-42-8(g)(3), will conduct a hearing on the above-referenced motions on **November 17, 2010 at 9:00 a.m.** in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.
