ORDER GRANTING COMPLAINANT'S MOTION TO
WITHDRAW PROHIBITED PRACTICE COMPLAINT, FILED ON MAY 24, 2011

On March 31, 2011, the Hawaii Labor Relations Board issued Order No. 2784, Order Deferring Prohibited Practice Proceedings to the Contractual Grievance Process. The Board indicated that it would entertain a motion to reopen this prohibited practice action after the contractual proceedings are concluded to address issues that were not addressed or remedied by the contractual proceedings.


On May 24, 2011, Complainant UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (UHPA), by and through its counsel, filed a Motion to Withdraw Prohibited Practice Complaint (Motion) with the Hawaii Labor Relations Board (Board). Complainant's counsel states in a declaration attached to the motion that the parties have reached a settlement in this matter; withdrawal of the instant Complaint is a condition of the settlement agreement; the settlement resolves all issues between the parties; each party will bear its own fees and costs; and opposing counsel does not oppose the Motion.

Hawaii Administrative Rules § 12-42-44 provides that a complaint can be withdrawn at any time prior to the issuance of a final decision and order upon motion and with the consent of the Board. Based on the foregoing, the Board hereby grants UHPA's Motion. The Board appreciates the parties' efforts to resolve these matters.
