COMPLAINT FILED ON SEPTEMBER 28, 2011, FILED ON OCTOBER 19, 2011

On October 19, 2011, Respondent UNIVERSITY OF HAWAII, State of Hawaii (University), by and through its counsel, filed a Second Motion to Extend Time to Answer or Otherwise Respond to Complaint Filed on September 28, 2011 with the Hawaii Labor Relations Board (Board). The University requested a second extension of the deadline to answer or otherwise respond to Complainant's Prohibited Practice Complaint filed on or about September 28, 2011 (Complaint). In Order No. 2820, dated October 12, 2011, the Board granted the University's prior request for an extension to October 21, 2011. Respondent's counsel stated in a Declaration, dated October 19, 2011, *inter alia*, that the parties are currently engaged in settlement discussions in an attempt to reach a resolution and that she called Complainant's counsel who did not object to granting an extension of time to Friday, November 4, 2011, to answer or otherwise respond to the Complaint.

Based upon the foregoing, the Board finds good cause to grant Respondent's second motion to extend the time to answer or otherwise respond to the Complaint, filed on September 28, 2011, to November 4, 2011.


