ORDER APPROVING STIPULATION TO WITHDRAW PROHIBITED
PRACTICE COMPLAINT, FILED ON AUGUST 24, 2009, WITHOUT PREJUDICE

On July 13, 2012, the above-named parties, by and through their respective counsel, filed a Stipulation to Withdraw Prohibited Practice Complaint Filed on August 24, 2009 Without Prejudice (Stipulation to Withdraw) with the Hawaii Labor Relations Board (Board). The parties stipulated and agreed to the withdrawal of the Prohibited Practice Complaint in Case No. CE-11-725 without prejudice on the conditions set forth therein, pursuant to Hawaii Administrative Rules § 12-42-44.

Hawaii Administrative Rules § 12-42-44 provides that a complaint can be withdrawn at any time prior to the issuance of a final decision and order upon motion and with the consent of the Board. Based on a review of the record and the Stipulation to Withdraw, the Board hereby approves the Stipulation to Withdraw and grants Complainant's withdrawal of its complaint filed on August 24, 2009, without prejudice.


