ORDER APPOINTING ARBITRATION PANEL  
AND NEUTRAL ARBITRATOR AND CHAIRPERSON

By letter dated December 3, 2012, Employer Representative Ronald K. Takahashi, Director of Human Resources, County of Hawaii submitted the Memorandum of Agreement, Alternate Impasse Procedures for Unit 11, dated November 30, 2012 (MOA) to the Hawaii Labor Relations Board (Board). The MOA provides, *inter alia*, that on November 21, 2012, the parties agreed to R. Douglas Collins, as the Neutral Arbitrator and Chairperson and that the arbitration panel for the Unit 11 arbitration would consist of R. Douglas Collins, Neutral Arbitrator and Chairperson, William J. Puette, Union Panel Member and Nicholas M. Hermes, Employer Panel Member.

Accordingly, based on the foregoing, the Board hereby appoints R. Douglas Collins, as the Neutral Arbitrator and Chairperson of the arbitration panel and certifies William J. Puette and Nicholas M. Hermes as members of the panel. The panel shall have such authority and duties as conferred by law.
