ORDER DECLARING AN IMPASSE AND APPOINTING A MEDIATOR

As no party has given written notice of an impasse and there are unresolved issues in the negotiations over a renewed agreement for Unit 02, pursuant to Hawaii Revised Statutes (HRS) § 89-11(c)(2), the Hawaii Labor Relations Board (Board) hereby declares that an impasse exists in negotiations. In accordance with the foregoing statute, February 1, 2013 is the date of impasse.

Pursuant to HRS § 89-11(e)(1), the Board hereby appoints Federal Mediator Carol Catanzariti to assist the parties in the voluntary resolution of the impasse.

In the event the parties enter into an Alternate Impasse Procedure (Procedure) modifying the statutory timelines pursuant to HRS § 89-11(a), the parties shall immediately notify the Board and file a copy of the Procedure with the Board.


