This Stipulation and request is submitted in order to provide the parties sufficient time to resolve the payment issue which is the subject of the PPC and to avoid an unnecessary usage of the HLRB's time and resources. In support of this Stipulation the parties agree to waive any statutory or administrative requirements governing the time period for processing the PPC.




